Indaver Are Back — With Bigger Burners

An application for 2 incinerators in Ringaskiddy was submitted in December 2008, directly to An Bord Pleanala as a Fast-Track Strategic infrastructure Application. The original planning expired on 15 Jan 2009.

The Municipal Incinerator will now burn 140,000 tonnes, and the Toxic Waste incinerator will burn 100,000 per annum.

What happens next?

The public must make submissions to An Bord Pleanala before 2 February, 2009.

The developers have had the benefit of a 'consultation period' with An Bord Pleanala.

Will there be another Oral Hearing?

Bord Pleanala will consider submissions and requests to hold an Oral Hearing. An Oral Hearing is not automatic, but would be hoped

How fast is the Fast-Track?

After the Oral Hearing, the inspector will make a recommendation, and the Bord will grant, or refuse planning. This process is expected to be complete by July 2009, with no recourse to planning appeal for any party (though costly court options do remain).

Wrong Site Then....Wrong Site NOW

The site FAILS 13 of the 14 WHO guidelines on site selection for Hazardous Waste incinerators.

Bord Pleanala's Planning Inspector (Jan 2004) gave an unprecedented 14 reasons for refusing planning.

Government Ministers Willie O'Dea, Batt O'Keeffe and Micheal Martin all expressed opinions that the site, zoned for Port-related industries under the County Development Plan, with a specific exclusion on commercial incineration, is wrong.

Why is it worse now?

Use of the surrounding area has increased in line with Cork Area Strategic Plan due to

- Opening of Maritime College (72m away)
- Opening of UCC Coastal Marine Research
- Traffic to Haulbowline Crematorium

 Relocation of Naval HQ to Haulbowline

Inspectors warnings about flooding became reality in October 2004. The site is just 5cm above high water mark now, with a rise in 28-43cm predicted by climatologists in the next 40 years.

The Irish Steel Toxic Waste debacle focused attention on the hazards of toxic waste, and related health issues in the community.

Cobh, less than 1km downwind of the incinerator site, already has a cancer incidence 44% above the national average.

(National Cancer Registry, 2008)

Planning was granted in 2004 against ABP Inspectors advice because of GOVERNMENT POLICY

Serious HAZID To Community And Students

Explosions will go beyond the incinerator boundry, posing a serious risk of burning, killing or injuring passing students, staff and naval personnel.

This is clear from the developers Hazard Identification (HAZID) report.

- Highly flammable hazardous chemicals will be stored only 70m from the road beside the Maritime College Car Park and Bus Stop. (HAZID 2008)
- Cork County Council Fire Services said they could not fight a fire at the incinera-

tor site due to its location at the end of a peninsula with single road access (Oral Hearing 2003)

Indaver were prepared to build despite the 2002 HAZID report showing that

- A vapour cloud explosion in certain weather would result in blowing out the windows of the Maritime College
- A pool fire over a specific area would result in heat radiation sufficient to cause
 2nd degree burns after 40 seconds at the edge of the Maritime College.

Time Running Out for Green Policy Changes

Policy shifts away from incineration, announced by Environment Minister John Gomley, have not yet been written into policy - on which An Bord Pleanala bases its rulings.

Consultants, Eunomia, who are currently preparing a Waste Policy Review for Government, stated in a 2007 report that Incineration runs the risk of crowding out recycling options, and recommended options such as Mechanical Biological Treatment (MBT), which can be brought to market quicker than incineration to meet the Landfill Directive.

With Minister Gommley outlining a maximum of 400,000 tonnes of waste available for final disposal, by incineration or other means, policy change must happen quickly or be futile.

A change in policy after Bord Pleanala have given incinerators the green light will be too late for good planning and for communities.

Pork Lessons
