### Global Day of Action on Waste - Sept 1st 2004



On September 1st more than 100 groups in 30 countries worldwide marked the Global Day of Action on Waste. Coordinated by the Global Alliance for Incinerator Alternatives (GAIA), this event highlights the growing problems associated with unsustainable waste creation and dangerous disposal systems, such as incinerators and landfills.

To mark the day, CHASE participated in a demonstration in Dublin on Saturday 4th September. Community groups from all over Ireland marched from the Garden of

Remembrance to Dail Eireann to highlight the current Irish Government's appalling track record on waste, the outdated policies being pursued and the weak enforcement regime tolerated here.

In the Monkstown/Glenbrook/Passage West area, the day was marked by the hand over of a cheque from Consumers for Health Choice to the local CHASE group. The presentation was performed by Jo Kelliher, Mayor of Passage Town Council.

## High Court to hear Incinerator case on 28 October

In March of this year, the Ringaskiddy and District Residents Association and 11 harbour residents applied to the High Court for a judicial review of An Bord Pleanala's decision to grant permission for a 100,000 tonne hazardous waste incinerator in Ringaskiddy.

After numerous deferrals and postponements, 28<sup>th</sup> October has been set as the date for An Bord Pleanala, The State and The Attorney General to present arguments as to why a judicial review should be denied. The Monkstown/Glenbrook/Passage West Group of CHASE actively supports the applicants in this case, and thank you, the residents of the area, for your great support following our Public Meeting earlier this year.

To safeguard our environment for ourselves and future generations, it is imperative that we continue to support this action!
